

## PERSONAL DATA PROTECTION CLAUSE

By submitting this form, I:

1. agree that Club Agape and the Church of the Holy Family (Collectively “the Church Club”) may collect, use, disclose, store and dispose of my personal data provided in this membership application form (“Form”);
2. confirm that I am authorized to disclose the personal data of the other parties in the Form; and
3. agree to the terms of the Roman Catholic Archdiocese of Singapore data protection policy (“Policy”) which is available on their website.

All personal data collected shall be used for the purposes of the Church Club’s activities and for the purposes set out in the Policy.

## WAIVER AND RELEASE OF LIABILITY

1. Assumption and Acknowledgment of All Risks
  - a. I knowingly, voluntarily, and freely accept and assume any and all risks, both known and unknown, of injuries or other loss or damage that may be suffered while at the Church Club’s premises (which includes the entire premises and property of the Church of the Holy Family) in relation to Club activities, however caused, even if caused in whole or in part by the action, inaction or negligence of the Church Club.
  - b. I certify that I am in good physical condition for the activities in which I will be participating and certify that I do not have any medical condition that may preclude me from safely participating in activities organized by the Church Club.
2. Waiver of All Claims
  - a. I hereby release, indemnify, discharge and agree to hold harmless the Church Club, it’s Management Committee, volunteers, service partners and agents from all claims or liabilities of any kind relating to the participation of events at the Church Club.
  - b. I expressly waive any and all claims, suits or demands for personal injury, property damage or other loss against the Church Club, including but not limited to any and all negligence, negligent supervision and/or negligent instruction, faulty equipment, or the activities of others. To the fullest extent permitted by law, this waiver is intended to be a complete release of the Church Club for any and all responsibility for personal injuries, property damage or loss, or death on the Church Club’s property in relation to Church Club’s activities, whether arising out of or resulting from my participation in activities organized by the Church Club. This release applies forever, for any date in the future including today’s date, and is further binding on my heirs, representatives and estate.
  - c. I expressly and voluntarily agree to waive, release, acquit and forever discharge the Church Club and agree to defend, indemnify and hold harmless the Church Club from and against all claims, damages, injuries, expenses, or death arising out of or resulting from administering of or failing to administer medical assistance to me. I grant the Church Club the right to request emergency medical services for me in the event the Church Club deems a situation medically necessary and I agree to cover any and all associated expenses.
  - d. I have carefully read this agreement, fully understand its terms, and sign it freely and voluntarily. I understand that I have given up substantial rights by signing it, and agree to be bound by its terms. If any portion of this agreement is found to be void or unenforceable by Singapore law, the remaining portion shall remain in full force and effect.
  - e. Information provided will strictly not be shared to third parties for marketing or other such gain. It is solely to establish proof of consent to the terms of this waiver.
